## What we achieve...

How much compensation you receive will depend on the effect that the negligent treatment has had on you. This will be determined by independent medical and professional experts. Recent cases include:

- Obtaining a settlement worth £4 million for a client who was left brain damaged after a hospital allowed him to fall from a roof.
- Obtaining compensation of over £2.4 million for a child who was left brain damaged after hospitals failed to monitor and treat his liver condition.
- Obtaining damages of £125,000 at trial after the Judge found out that our client was not properly warned of the risks of plastic surgery to his face.
- Obtaining compensation of £1 million for the family of an anaesthetist who was allowed to bleed to death in her own hospital after giving birth to twins by caesarean section.
- Obtaining £3.3 million for a 9 year old boy who suffered catastrophic brain and spinal cord injury after contracting meningitis which a hospital failed to diagnose and treat in time.
- Obtaining a settlement of £115,000 for a client whose ankle injury became worse after the hospital failed to detect and treat a fracture.

## How you pay...

Anthony Gold was one of the first firms to be granted a Community Legal Service franchise for clinical negligence work. This means that, if you are eligible, we can apply for public funding for you to bring a claim. We have also been at the forefront of the development of conditional fees (No Win, No Fee arrangements) and also act for private paying clients and those with legal expense insurance.
