No amount of money can really compensate for injuries caused by someone else's mistake. However, compensation can help to reduce the effects of an injury, particularly if it has caused you financial loss.

If you have been injured in an accident and someone else is to blame, you can normally claim compensation. You can also bring a claim even if the accident was partly your fault, but the compensation will be reduced to take account of your share of the blame.

Personal injury cases can often be traumatic. All of our clients are represented by a lawyer who specialises exclusively in injury compensation claims and we ensure that you have the opportunity to meet with us face-to-face and to speak to us whenever you need to.

We instruct the medical experts and barristers who are best suited to your case. We will always try and settle your claim as quickly as possible, but we will also ensure that you receive all the compensation you are entitled to. Where appropriate, we will also arrange any rehabilitation you may need.

## What we achieve...

How much compensation you receive will depend on how bad your injuries are and on the amount of your financial losses. This will be determined by independent experts. We deal with claims ranging in value from £1,000 for minor claims to millions of pounds for catastrophic injuries. Recent cases include:

- Obtaining damages of over £230,000 at trial on behalf of a former printer whose ankle had been badly broken in a road traffic accident when the insurers refused to settle out of court.
- Obtaining a settlement of £125,000 for a whiplash injury from our client's previous solicitors, when they negligently allowed his original claim to be struck out.
- Obtaining compensation of £1.3 million for an amputee who lost a limb in an accident at work.
- Obtaining £240,000 for a 26 year old client who sustained a severe back injury during the course of employment which left her with permanent residual problems.
- Obtaining £10,000 for a 75 year old lady who slipped on water in a supermarket and fractured her shoulder and wrist, leaving her with permanent problems.
- Obtaining £2.4 million for a young man who suffered a low level paraplegia in a road traffic accident.
- Obtaining £800,000 for a client who was thrown out of a camper van which overturned whilst she was on holiday and who suffered multiple orthopaedic injuries, a head injury and PTSD.
- Obtaining £20,000 for a 65 year old client who sustained a whiplash injury in a road traffic accident, leaving him with permanent problems and requiring domestic support from his family.

## How you pay...
